1. PURPOSE

Alkemy S.p.A. (hereinafter also the "Company" or "Alkemy") is an international public company and the parent company of the Alkemy Group (hereinafter also the "Group" or "Alkemy Group"), that operates in Italy, Spain, Mexico, USA and the Balkans through its 11 offices located in Milan, Turin, Rome, Naples, Potenza, Cagliari, Rende, Madrid, Belgrade, Mexico City and New York. Across all of its geographies, the Group has a strong commitment to:

- reducing natural resource consumption by implementing energy-saving practices and also improving efficiency of its offices through green initiatives regarding water and waste and minimization of paper and plastic use;
- encouraging sustainable practices by increasing environmental awareness of employees and promoting less impactful means of transport.

The purpose of this Green Office & Mobility Policy is to foster ongoing improvements in the Group's environmental resolutions and outcomes and to provide guidelines in order to reduce the negative effects of office work on the environment.

Alkemy Group commits to adopting good practices in managing energy, water and waste and to choosing, whenever possible, sustainable forms of transportation.

2. RECIPIENTS AND SCOPE OF APPLICATION

This Policy applies to Alkemy S.p.A. and its subsidiaries and its provisions and commitments are fully supported by the Group's top management.

In particular, the Green Office & Mobility Policy is aimed at inspiring employees, corporate boards, collaborators, job applicants, contractors and suppliers, and all persons who maintain relations with the Group to adopt environmentally sound habits and leading to high motivation towards more sustainable working habits.

Regarding supplier selection and procurement processes, Alkemy and its subsidiaries are committed to take into consideration environmental and human health's impacts, following sustainability principles whenever possible and convenient, as stated in the Supplier Code of Conduct.

3. GREEN OFFICE COMMITMENT

3.1. ENERGY

The Alkemy Group is aware of the importance of using energy and other natural resources responsibly in order to protect the environment. The Company's commitment to these concerns is founded on the values outlined in its Code of Ethics, which requires all employees and collaborators to engage in the risk-prevention and environmental-protection processes.

The use of energy is a material issue for the Group since it may have a considerable impact on the environment and, as a result, on climate change.

The consumption of energy resources is mainly attributable to heating, office lighting, the functioning of company computers and to the use of fuels for company cars.

To reduce energy consumption Alkemy commits at Group level to promote environmental best practices including encouraging all employees to:

- Turn off computers and monitors when leaving the desk, also for short periods of time;
- Unplug laptop and phone chargers when not in use;
- Switch to energy-saving settings;
- Turn off and unplug peripherals when not in use;
- Turn off the lights when they leave a room if there is a lack of automation in this sense.

In particular, the lighting issue was furtherly addressed by implementing a smart lighting system in the headquarters that helps reducing power consumption by automatically turning all lights off when the rooms are empty.

SERVERS

Alkemy Group is aware that ICT infrastructures are responsible for a large portion of global emissions of CO2 and that reducing the number of physical servers as well as lowering the energy consumed directly by servers and indirectly for cooling increases the utilization and efficiency of the remaining servers.

That is why the Group is using cloud-based services (instead of proprietary servers) when feasible, in order to optimize hardware utilization, which results in lower energy consumption and environmental benefits.

3.2. WATER

Alkemy and its subsidiaries are committed to having and promoting a diligent consumption of water within its offices, recognizing that "water is not a commercial product like any other but, rather, a heritage which must be protected, defended and treated as such" (EU Water Framework Directive – Directive 2000/60/EC).

In order to do so, undertakes to:

- Fixing leaks and check the building's water system regularly;
- Regularly maintain HVAC systems;
- Ensure that everyone at the organisation is aware of the need to be water efficient.

3.3. WASTE

The Alkemy Group strives to reduce waste generation, recognizing it is one of the most straightforward ways to save natural resources and to diminish the Ecological Footprint.

As the European Waste Framework Directive (2008/98/EC) advises, the Group follows the "waste hierarchy" principles with the aim of encouraging the management of waste materials, reducing the amount of waste produced, and recovering the maximum value from the waste streams that are produced.

The "waste hierarchy" principles consist in following five steps:

- 1. Eliminate avoid producing waste in the first place;
- 2. Reduce minimize the amount of produced waste;
- 3. Re-Use use items as many times as possible;
- 4. Recycle recycle what you can only after you have re-used it.
- 5. Dispose dispose of what's left in a responsible way.

PLASTIC

Alkemy and its subsidiaries make a conscious effort to limit plastic use, therefore all employees are encouraged to avoid single-use plastic, to repurpose and re-use containers, packaging or waste products. In many offices water dispensers have been installed and employees have been provided with refillable water bottles.

PAPER

The Alkemy Group commits to reduce paper use by encouraging all employees to process, share and store documents electronically, instead of printing hard copies, to use both sides of a paper when printing is necessary and to give paper a second chance within the office (to reuse paper that has only been printed on one side for faxes, draft copies, internal documents or as scratch paper). In addition, Alkemy and its subsidiaries preferably purchases recycled paper for a daily use.

IT EQUIPMENT

The Alkemy Group actively strives to reduce the environmental impact of its IT equipment along its entire lifecycle. Since a significant proportion of the lifetime carbon emission of ICT equipment is released in its manufacture, providing a regular maintenance can extend equipment lifecycle, so does reconditioning or repairing, whenever possible.

When equipment has reached end of life and must be either recycled or disposed, the Group undertakes to responsibly manage the process, according to local regulations.

4. MOBILITY COMMITMENT

BUSINESS TRAVELS

Alkemy and its subsidiaries are determined to achieve their organizational aims, while following a low-carbon path.

The Group's core business is the provision of services to clients. These services are often carried out in each company's offices and, in part, delivered in-person at the offices of the clients themselves. In order to reduce environmental consequences of transportation, Alkemy and its subsidiaries outlined some rules of conduct to influence the daily choices of their employees and encourage an increase in companies' awareness towards the impact of motorized traffic in the urban environment.

Whenever possible, Alkemy and its subsidiaries enable working from home by putting in place ICT structures that allow its employees to meet and work together without physically being in the same office, therefore reducing the need for day-to-day travel.

Telework and videoconferences contribute to a greener environment by decreasing vehicle carbon emissions as a result of avoiding employee commuting.

If travel cannot be avoided, means of travel with lower GHG emissions (CO2 equivalents per km) are encouraged: the use of public transport in the city shall be preferred, compared to the use of the private car or taxi and, when possible, train travels are preferred, compared to air travels.

CAR FLEET

The Alkemy Group is aware of the impact of use of fossil fuels within the regular course of its business. For this reason, the Group encourages the selection of hybrid vehicles or zero emissions vehicles for its car fleet. In fact, thanks to an increasing awareness of the Group's employees, the adoption of hybrid and electric company cars over conventional gasoline or diesel-powered cars has been growing significantly over the years.

5. EMPLOYEE ENGAGEMENT

The Alkemy Group acknowledges that awareness of employees is pivotal for a successful implementation of Green Office and Mobility practices. For this reason, the Group is proactively committed on informing its personnel on environmental issues and promoting sustainable working operations through its policies and initiatives.

Encouraging employees and co-workers to adopt green behaviours is key to improve the environmental footprint of the Alkemy Group. The Group promotes and integrates in its company culture behaviours that allow to save energy, water, waste and to minimize paper and plastic use.

6. APPROVAL AND DIFFUSION

Alkemy and its subsidiaries promote the adoption and the diffusion of this Policy to all addressees and to all persons who maintain relations with them.

These Guidelines are also made available on the corporate website, with a view to spreading and promoting further Alkemy's culture of Green Office & Mobility, and will be the subject of periodic updating, also on the basis of the results of internal assessments and monitoring actions undertaken.
